<Actual Expenses and Incidental Costs>

The following expenses shall, in principle, be borne by the Client.

◆ Transportation Expenses

・Transportation expenses required for travel necessary to perform guide services shall be charged at actual cost.

・The means of transportation shall be selected with priority given to time efficiency and operational effectiveness.

◆ Meal Expenses

・When guide services overlap with meal times, the following meal expenses or meal allowances shall apply.

Breakfast: JPY 2,000

Lunch: JPY 3,000

Dinner: JPY 4,000

・Meal expenses are subject to the provisions of the Tour Guide Service Regulations.

・Definitions of meal times and detailed handling shall be governed by the Tour Guide Service Regulations.

◆ Accommodation Expenses

・For services involving overnight stays, accommodation shall, in principle, be arranged by the client.

・If the client is unable to arrange accommodation, the guide may arrange it upon prior consultation.

・Accommodation conditions and detailed handling shall be governed by the Tour Guide Service Regulations.

◆ Luggage Delivery Fees (Suitcases, etc.)

・Courier delivery fees for suitcases or other large luggage required for the performance of services

◆ Communication and Material Preparation Costs

・Communication costs necessary for business-related communications

・Copying costs related to the preparation and distribution of materials (including maps)

◆ Other Necessary Expenses

・If other expenses become necessary for the performance of services beyond those listed above, such expenses shall be borne by the Client upon prior consultation.
